Donning Instructions




Step 1. Grasp top of mask with one hand. Slide top edge of mask over forehead and over ears.




Step 2. Open mask by pulling lower edge and use other hand to pull mask to fully open. If in NIOSH (N95) that mask is fully open.




Step 3. Place over face in pocket position. Bend back over back of head, position, behind head behind neck behind ears and top band over crown of head.




Step 4. Cover nose and mouth to ensure full contact, making it the Magic Arch® to fully extend along your nose and mouth.




Step 5. Adjust mask to ensure proper fit. Adjust the mask on the forehead above the eyes, and ensure properly fit that mask in NIOSH approved form.



Step 6. Check any necessary sealant together under chin and ear over head.




Step 7. Final Check. To check fit, place hand against the top edge of the respirator and inhale. If air escapes around your nose, top of the mask, or under the chin, repeat steps 1 and 2.



Step 8. PFL. Look closely at face.
